2. 申請騎樓用地減免者，請註明房屋層數並檢附建築物使用執照影本或建物所有權狀影本以供辦理。

1. For reduction of or exemption from land value tax applied for on passages under balconies, the landowner shall apply at least forty days before the collection starting date each year (i.e. September 22); for those applications that were made past the aforesaid deadline, the tax rate will be applied starting from the following year (batch).

2. Applying for reduction of or exemption from land value tax on Passages under Balconies, the applicant shall indicate the number of floors and attach a copy of the building use permit or a copy of ownership certificate of the building for processing.
